Ultimate guiding authority for all laws, setting forth the principles and fundamental laws of the federal and state governments.

US Constitution

Full text of federal and state constitution is in the Colorado Revised Statutes (CRS)
Full text of federal constitution is in any major general encyclopedia as well as on the Web

Laws of the land—federal, state, local, passed by lawmakers (legislators). All laws must be congruent and in harmony with the Constitution—cannot be contradictory.
